I authorize the Bank to send bank statements for the deceased's account using any of the above means of communication.

Notices sent to me by the Bank in the above means of communication, and in particular by online means of communication, in connection with the deceased and / or his / her account will not be password protected and may include personal and financial details about the actual existence of the deceased's account at the Bank and financial data from the deceased's account. We are aware that notices sent by telephone or online media may be exposed to third parties as well as to the communication providers with whom we are affiliated, and we accept the risks involved and release the Bank from any liability and damage in connection with the fact that such information may be disclosed to third parties.

The Bank will be exempt from any liability for damage, loss or expense, which may be caused to us or any third party who receives information, details or data from us, as a result of disruption of information, dates of receipt or actual arrival of information, both in details and data, for any reason due to or pursuant to malfunctions arising from lines of communication, means of communication or communication equipment or other communication limitations that are not under the Bank's control or that are related to other third parties, which are not under the Bank's control or knowledge, including not receiving messages at times requested by us or receiving them partially, disrupted or out of date, in which the Bank was unable to prevent the disruption or malfunction with reasonable effort.

The Bank may stop providing information and the possibility of performing operations in the service channels or any of the service channels, in whole or in part, by giving prior notice. Alternatively, the Bank may stop providing information and the possibility of performing operations in all or part of the service channels, if the Bank has concerns or suspicion regarding one or more of the service channels, of unlawful use, use in a manner that may cause damage, or for compliance with the order of a competent authority.

Notices sent by the Bank are made for convenience only. Reliance should not be made on a particular notice, its sending or the Bank's refraining from sending it. In any contradiction between the data recorded in the notices sent by the Bank to that recorded in the books of the Bank, the data recorded in the Bank's books shall prevail.

We confirm that:

- We are not required by law to provide our contact details to the Bank in any of the service channels, however the Bank will not be able to provide us with details about the deceased's account or provide us with a service in a service channel for which no details have been provided.
- All the details we have provided above are correct and accurate and the Bank may rely on them in contacting us, in order to provide details of the account of the deceased.
- The information we have provided and which we will provide to the Bank will be retained in the Bank's databases and will be used by the Bank to contact us in connection with the deceased's account and in connection with the deceased's account.
